- With the planned renovation at the Perry branch, motion was made by G. Hagadon, to approve payment from the O'Berry account to Corrigan Moving for rent of book carts and bins to store materials from branch, in the amount of \$4125.00, seconded by A. Voorhies, roll call, motion accepted.

Directors Report:

- Jami introduced Maria Cutbert, who will be replacing Mike Tobias as the representative from Perry City, and new Board Member Elaine Prine from Hazleton Township.
- A new staff member has been added to the New Lothrop Branch, Karen Bailey began her duties the first week of January.
- Byron branch is temporarily closed until a new Branch manager is hired. Staff are maintaining the book returns and handling of daily tasks for now.
- The furnace at the Corunna branch is to be repaired, giving the hallway and front of the library heat. The plans for the "Green Space" at the Yott lot are still being discussed.
- The Overdrive magazine catalog will no longer be provided, as costs do not outweigh circulation. This service had been provided by a grant obtained by the Saginaw Chippewa Tribal Libraries.
- The 4th quarter penal fines were considerably lower than usual, this may be due to the holidays and Covid closings of courts.
- Branches are busy with Winter and Spring program planning. A new Winter reading program for adults will begin February 1, with great "Cozy" incentives.
